SUBJECT: Consideration of Preliminary FY 2021-22 Budget for AGTBID

#### **RECOMMENDATION**

That the AGTBID Advisory Board review the preliminary FY 2021-22 Budget for AGTBID and forward a recommendation to the City Council for final approval.

#### **BACKGROUND**

The AGTBID Advisory Board is responsible for developing an annual preliminary budget detailing anticipated expenditure and submitting the preliminary budget to City Council for approval.

#### **DISCUSSION**

A preliminary budget is attached for the Board's review and recommendation to City Council. The preliminary budget is based on the FY 2020-21 approved budget and can be modified based on the Board's projections of expenses in FY 2021-22. TBID assessments are projected to return to similar levels, yet still slightly lower, as in FY 2019-2020 (prior to March 2020) now that San Luis Obispo County is slowly reopening to tourism after a yearlong negative impact from COVID-19.

Due to the absence of a marketing firm in FY 2017-18, the AGTBID currently has an estimated fund balance from leftover money not spent on marketing. The current estimated fund balance is \$250,000. In order to continue the momentum of the Board's tourism marketing efforts and to fund anticipated additional marketing opportunities, staff is recommending the Board approve the preliminary budget including a recommendation to City Council to appropriate \$87,750 from the fund balance into the AGTBID FY 2021-22 operating budget.

The Chamber is requesting to remove their \$5,000 annual contribution as this was a carryover from the formation of the TBID and is no longer necessary. This change is reflected in the attached preliminary budget.
