NOTICE OF PUBLIC HEARING**

NOTICE IS HEREBY GIVEN that the Arroyo Grande Planning Commission will conduct a public hearing on **TUESDAY, SEPTEMBER 7, 2021 at 6:00 p.m.**, or soon thereafter, to consider the following item:

CONSIDERATION OF CONDITIONAL USE PERMIT 21-006; ESTABLISHMENT OF A FITNESS FACILITY; LOCATION – 134 NELSON STREET; APPLICANT – TARA WARWICK, TARAFIED FITNESS, LLC

The Planning Commission will consider an application for a Conditional Use Permit to establish a 1,035 square foot fitness facility at the subject location in an existing structure in the Village Mixed Use zoning district.


In compliance with the California Environmental Quality Act (CEQA), the Community Development Department has determined the project is categorically exempt per Section 15301(a) of the CEQA Guidelines regarding existing facilities.

Due to concerns regarding the COVID-19 pandemic, the City of Arroyo Grande is conducting all public meetings via teleconference, until further notice. The Planning Commission meeting can be viewed on Government Access Channel 20. The meeting will also be streamed live online from the City's website at www.arroyogrande.org and www.slo-span.org.

During the public hearing, public comment will be limited to three (3) minutes per speaker, pursuant to current meeting procedure.

The Planning Commission may also discuss other hearings or business items before or after the item listed above. If you challenge the proposed action in court, you may be limited to raising only those issues you or someone else raised at the public hearing described in this notice, or in written correspondence delivered to the Planning Commission at, or prior to, the public hearing. Failure of any person to receive the notice shall not constitute grounds for any court to invalidate the action of the legislative body for which the notice was given.
